

Assistant Chief Matson advised that the way the law is currently written is a problem because the violation must occur in front of the Officer, which rarely happens. This is the five (5) year update to the Snellville 2040 Comprehensive Plan, adopted February 2019 and a requirement to maintain qualified local government status and eligibility for state funding.

The 2045 Comprehensive Plan process began in July 2023 and involved community engagement, research on existing conditions, strategy development, and coordination with elected officials, Community Task Force members, City departments and partner organizations. Draft elements were posted to the Snellville 2045 project website (<a href="https://www.snellville2045.org/">https://www.snellville2045.org/</a>) for review throughout the process and feedback was incorporated into the final draft.

The draft plan was transmitted to the Atlanta Regional Commission (ARC) and Georgia Department of Community Affairs (DCA) for regional review and comments. Comments have been addressed with the final draft plan having been approved by the ARC on February 13, 2024.

The plan does not make any zoning map changes to the Official Zoning Map for the City of Snellville; however, the plan does include 11 updates to the February 2019 adopted 2040 Future Land Use Map as shown in Exhibit "A".

### ADOPTION RESOLUTION SNELLVILLE 2045 COMPREHENSIVE PLAN

WHEREAS, the governing authority of the City of Snellville, Georgia is the Mayor and Council thereof; and

WHEREAS, the Georgia Planning Act of 1989 authorizes local governments throughout the State to prepare Comprehensive Plans to be used in guiding their future growth and development; and

WHEREAS, the City of Snellville, Georgia is a member of the Atlanta Regional Commission, an agency created to provide regional planning and intergovernmental coordination among certain county and city governments in the metropolitan area of Atlanta, Georgia; and

WHEREAS, the preparation of the 5-year update to the February 11, 2019 adopted 2040 Comprehensive Plan for the City of Snellville, Georgia was initiated in the Summer of 2023 with the assistance of Jacobs Engineering Group, Inc. of Atlanta, Georgia; and

WHEREAS, the City conducted a public hearing on August 14, 2023 to brief the community on the process to be used to develop the Snellville 2045 Comprehensive Plan, opportunities for public participation in development of the plan, and obtain input on the proposed planning process; and

WHEREAS, the City employed a variety of community outreach efforts including posted website information, surveys, questionnaires, social media, public meeting announcements, and press releases to facilitate and encourage discussion and community input; and

WHEREAS, the plan was prepared by Jacobs Engineering Group, Inc. to cover the period through the year 2045 in accordance with the Standards and Procedures for Local Comprehensive Planning effective March 1, 2014 and established by the Georgia Planning Act of 1989; and

#### ORDINANCE NO. 2024-01

## AN ORDINANCE TO AMEND CHAPTER 38 OF THE CODE OF ORDINANCES OF THE CITY OF SNELLVILLE, TO REPEAL CONFLICTING ORDINANCES, AND FOR OTHER PURPOSES

WHEREAS the Mayor and the Council of the City of Snellville, Georgia, the governing body of the City of Snellville, Georgia, desire to amend Chapter 38 of the Code of Ordinances of the City of Snellville; and

WHEREAS, the Mayor and the Council of the City of Snellville, Georgia is authorized by O.C.G.A. § 36-35-3 to adopt ordinances relating to its property, affairs, and local government; and

WHEREAS, the Mayor and Council of the City of Snellville, Georgia deem such amendment to be for the betterment and general welfare of the City of Snellville and its inhabitants;

IT IS HEREBY ORDAINED BY THE GOVERNING AUTHORITY OF THE CITY OF SNELLVILLE, GEORGIA, and by the authority thereof:

<u>Section 1.</u> Chapter 38 of the Code of Ordinances of the City of Snellville is hereby amended by adding a new Section 38-96 and inserting the following language:

#### **Section 38-96 Improper Use of Public Places**

- a) Definitions.
  - 1. <u>Camp</u> means residing in or using a location for private living accommodations, such as erecting tents or other temporary structures or objects providing shelter; sleeping in a single place for more than one hour at a time; cooking or preparing meals; or other similar activities.
  - 2. <u>Storing personal property</u> means leaving one's personal effects, such as, but not limited to, clothing, bedrolls, cookware, sleeping bags, luggage, knapsacks, or backpacks, unattended for more than one hour.
- b) Prohibited Activities
  - 1. *City parks*. It shall be unlawful to camp or to store personal property in any park owned by the City of Snellville.

- 2. Towne Green & the Grove Lawn. It shall be unlawful to camp or store personal property on the Snellville Towne Green or the Grove Lawn.
- 3. *Streets and sidewalks*. It shall be unlawful to camp, sleep, store personal property, or to sit or lie down on any street or sidewalk or public right-of-way.
- 4. Other public property; blocking ingress and egress. It shall be unlawful to camp, sleep, store personal property, or to sit or lie down on any public property so as to interfere with the ingress or egress from buildings.
- c) Warning. No person may be arrested for violating this section by simply sleeping, sitting, or lying down in a prohibited location or for a prohibited period of time without having first received an oral or written warning to cease such unlawful conduct.
- d) *Exceptions*. Notwithstanding anything in this section to the contrary, this section shall not apply to nor be construed to prohibit the following behavior:
  - 1. Persons sitting or lying down as a result of a medical emergency;
  - 2. Persons sitting in wheelchairs while using sidewalks;
  - 3. Persons sitting down while attending parades;
  - 4. Persons sitting down while patronizing outdoor cafes;
  - 5. Persons sitting down, lying down, or napping while attending performances, festivals, concerts, fireworks or other special events taking place in any park, the Snellville Towne Green, the Grove Lawn or on any street or sidewalk closed by permit for such purpose;
  - 6. Persons sitting on chairs or benches supplied by a public agency or abutting private property owner;
  - 7. Persons sitting on seats in bus zones occupied by people waiting for the bus;
  - 8. Persons sitting or lying down while waiting in an orderly line outside a box office to purchase tickets to any sporting event, concert, performance, or other special event;
  - 9. Persons sitting or lying down in an orderly line awaiting entry to any building, including shelters, or awaiting social services, such as provisions of meals; or
  - 10. Children under the age of 13 years sleeping in parks or sleeping anywhere else while being carried by an accompanying person or while sitting or lying in a stroller or baby carriage.
- e) *Enforcement*. The Snellville Police Department shall be responsible for the enforcement of this section.
- f) Penalty. Any person who violates any provision of this section may be subject to arrest or summoned to appear in the Municipal Court of the City of Snellville and upon conviction or other finding of guilt, be punished by a fine of up to \$1,000.00 or 30 days of imprisonment, or both.

- <u>Section 2.</u> (a) It is hereby declared to be the intention of the Mayor and Council that all sections, paragraphs, sentences, clauses, and phrases of this Ordinance are or were, upon their enactment, believed by the Mayor and Council to be fully valid, enforceable, and constitutional.
- (b) It is hereby declared to be the intention of the Mayor and Council that, to the greatest extent allowed by law, each and every section, paragraph, sentence, clause or phrase of this Ordinance is severable from every other section, paragraph, sentence, clause or phrase of this Ordinance. It is hereby further declared to be the intention of the Mayor and Council that, to the greatest extent allowed by law, no section, paragraph, sentence, clause, or phrase of this Ordinance is mutually dependent upon any other section, paragraph, sentence, clause, or phrase of this Ordinance.
- (c) In the event that any phrase, clause, sentence, paragraph or section of this Ordinance shall, for any reason whatsoever, be declared invalid, unconstitutional or otherwise unenforceable by the valid judgment or decree of any court of competent jurisdiction, it is the express intent of the Mayor and Council that such invalidity, unconstitutionality or unenforceability shall, to the greatest extent allowed by law, not render invalid, unconstitutional or otherwise unenforceable any of the remaining phrases, clauses, sentences, paragraphs or sections of the Ordinance and that, to the greatest extent allowed by law, all remaining phrases, clauses, sentences, paragraphs and sections of the Ordinance shall remain valid, constitutional, enforceable, and of full force and effect.

<u>Section 3.</u> All ordinances and parts of ordinances in conflict herewith are hereby expressly repealed.

<u>Section 4.</u> This Ordinance was adopted February 26, 2024. The effective date of this Ordinance shall be the date of adoption unless otherwise stated herein.
