PUBLIC HEARING**

Notice is hereby given to the general public that the City of Snellville has received an application (#RZ 17-12 CUP 17-04) from South Gwinnett Baptist Church, Inc. requesting to amend the Official Zoning Map from RS-180 (Single-family Residence) District to CI (Civic-Institutional) District and request for variances from the City Code of Ordinances relating to landscape strip requirements, parking lot planter islands, sidewalks, curb and gutter, parking location, and exterior building and site lighting.
