Dear Mayor Pro Tem Bender:

As required by O.C.G.A. § 36-36-7, our operating departments have reviewed the subject property with respect to county facilities located on the subject property. Gwinnett County owns no facilities within the subject property.

The Gwinnett County Department of Water Resources indicates an eight-inch water main is in the rights of way of Ridgedale Drive and Pinehurst Road along the frontage of the subject property. In addition, an eight-inch gravity sewer collector is located to the south along Carolina Wind Court.

The Gwinnett County Department of Transportation (GCDOT) has reviewed the proposed City of Snellville annexation ANX-2018-006. No GCDOT facilities are located within the properties proposed for annexation. This annexation has frontage on Ridgedale Drive and Pinehurst Road, both of which are currently GCDOT maintained roadways. Any proposed access or work in the right of way of either road would be subject to prior review and approval of GCDOT. In the future, should frontage on both sides of Ridgedale Drive and Pinehurst Road be annexed into the City of Snellville, then those portions of Ridgedale Drive and Pinehurst Road would become maintained by the City.

The Gwinnett County Department of Planning and Development notes that the subject property is presently zoned R-SR (Senior Oriented Residence District). The Department of Planning and Development further notes that the Future Development Map of the Gwinnett 2030 Unified Plan indicates that the subject property is in the Existing/Emerging Suburban Character Area.

If this annexation occurs, please notify Police Communications Manager, Major Lara Bardugon, of the street address of the subject property so that the E-911 database can be updated.
