The Public is hereby notified that on **February 11, 2019, at 7:30 p.m.** at Snellville City Hall, 2342 Oak Road, Snellville, the Mayor and Council for the City of Snellville, Georgia will hold a public hearing for the adoption of the City of Snellville 2040 Comprehensive Plan. Once adopted, the new plan will supersede the current Comprehensive Plan and serve as the active, guiding document for the City of Snellville.

Jacobs Engineering will present the plan which addresses land use, transportation, housing, and economic development. The presentation will include a discussion of Needs and Opportunities, Community Vision and Goals, proposed changes to the Future Development Map and Future Land Use Map, and major items for the five-year Community Work Program.
