Stormwater Management Facility Screening and Location Amendment Unified Development Ordinance Locational Requirements –

- A registered professional shall determine availability of feasible locations based on site conditions.
- Stormwater management facility shall be located, to the greatest extent feasible, in order to minimize the amount of stormwater volume generated by the development of the subject site that bypasses the stormwater management facility

Safety – All detention ponds greater in depth than 4 feet, measured either from the toe of slope to the top of dam or from the bottom of wall to the top of wall for walled facilities, require fencing.

Fencing must be made of a low maintenance material, i.e. coated chain-link, PVC, or any other approved composite fencing material.

Screening – All stormwater management facilities shall be screened from the traveling public. Screening can be provided through landscaping or opaque fencing, or a combination of the two.

- All stormwater management facilities that can be seen from a non-local/neighborhood street must be screened with a combination of shrubs, trees, or fencing.
- Any stormwater management facility located within 50' of a non-local/neighborhood street shall be screened with a combination of trees, shrubs, or fencing to achieve 80% screening coverage at the time of final plat approval or certificate of occupancy issuance. 100% coverage shall be achieved within 24 months thereafter.

The shortfall this year is around \$1.3 million dollars which is no longer sustainable. The City has to implement a solid waste collection fee of \$20 per month or an annual cost of \$240 that will appear on everyone's tax bill starting this year. She went on to explain other increases in the budget such as The Grove and salaries to assist with employee retention in the Police, Park and Public Works Departments. Agenda Item: 1st Reading-Chapter 6-Alcoholic Beverage Ordinance

<u>Background:</u> An update to the Alcoholic Beverage Ordinance was made in 2020 to establish an Entertainment District that allows for the consumption of alcoholic beverages (sold only by licensed businesses within the district) outside of the physical space of the establishment. Snellville's Entertainment District centers around The Grove and will soon be served by multiple restaurants as well as a brewery and food hall.

Existing policy and the proposed changes mirror best practices across other municipalities with entertainment districts, including several other cities in Gwinnett County.

Recommended changes included in the ordinance update are:

- o Update from only paper or plastic containers to "non-glass containers"
- Additional requirement that before sale, establishments in the Entertainment
  District must affix a specialty sticker (to be designed and managed by the City)
  indicating the beverage was purchased lawfully for consumption in the district

An amendment to the Entertainment District boundaries to include Greenway Trail: Downtown Loop (or portion) will be considered alongside second read of the proposed ordinance updates.

#### **ORDINANCE NO. 2025-14**

AN ORDINANCE TO AMEND THE ALCOHOLIC BEVERAGE ORDINANCE (CHAPTER 6); TO PROVIDE FOR AND AMEND ORDINANCES RELATED TO OUTSIDE CONSUMPTION OF ALCOHOL; TO PROVIDE SEVERABILITY; TO REPEAL CONFLICTING ORDINANCES; TO PROVIDE AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

**WHEREAS**, the duly elected governing authority of the City of Snellville, Georgia (the "City") is the Mayor and Council; and

**WHEREAS**, the Mayor and the Council of the City of Snellville, Georgia, desire to amend portions of its alcoholic beverages ordinance; and

WHEREAS, the Mayor and Council have determined that the health, safety, and welfare of the citizens of the City to ordain certain zoning rules and regulations to be consistent with updated legislation regarding the zoning procedures act; and

WHEREAS, the Mayor and Council of the City of Snellville, Georgia deem such amendment to be for the betterment and general welfare of the City of Snellville and its inhabitants; and,

## IT IS HEREBY ORDAINED BY THE GOVERNING AUTHORITY OF THE CITY OF SNELLVILLE, GEORGIA, and by the authority thereof:

Section 1. Section 6-195 of Article 6 of Chapter 6 of the Ordinance of the City of Snellville, Georgia is hereby deleted and replaced with the following:

"Sec. 6-195. - No outside consumption of alcohol; outdoor alcohol drinking areas.

- (a) Except as provided in this section, it shall be unlawful for any person to consume any alcoholic beverage or possess any alcoholic beverage in an open container in or upon any street, alley, sidewalk or other public way or place in the city or within any public building.
- (b) Except as provided in this section, it shall be unlawful for any licensed establishment to dispense any alcoholic beverage in an open container for removal from the premises, and it shall be unlawful for any person to remove any open container of an alcoholic beverage from an alcoholic beverage establishment. It shall be the licensee's responsibility to ensure that no open beverages are sold and carried out.

- (c) Except as provided in this section, it is prohibited for customers to gather outside an alcoholic beverage establishment and consume alcoholic beverages.
- (d) Consumption of alcohol in an open container outside of a licensed establishment shall be allowed only in the locations specified below:
- (1)On the patio of a licensed establishment which meets all of the requirements and is specifically licensed for patio sales in accordance with <u>section 6-197</u> of this Code;
- (2) In a designated special event outdoor alcohol drinking area as defined by and in accordance with section 6-196 of this Code.
- (3) Within the Snellville Towne Center Entertainment District in accordance with the following provisions:
  - a. The boundaries of the Snellville Towne Center Entertainment District are established by a map adopted by resolution of the mayor and city council. A copy of said map is attached hereto and shall be maintained in the office of the city clerk. If no such resolution and map has been adopted or if such resolution and map are repealed, there shall be no area in the city to which this subsection applies.
  - b. The alcoholic beverage shall be purchased from an establishment licensed for consumption on the premises and located within the Snellville Towne Center Entertainment District. Any establishment licensed to sell alcoholic beverages by the drink for consumption on the premises located within the Snellville Towne Center Entertainment District is authorized to dispense alcoholic beverages in a non-glass container bearing a special city sticker allowing the consumption of the alcohol outside of the premises ("specialty stickers").
  - c. The alcoholic beverage shall be in a non-glass container and shall not be larger than 16 ounces.
    - d. Only one drink at a time per person may be carried out of an establishment.
  - e. It shall be unlawful for any person to drink or attempt to drink any alcoholic beverage from an glass container or to possess an open glass container containing any alcoholic beverage in the Snellville Towne Center Entertainment District.
  - f. It shall be unlawful for any person to take an alcoholic beverage served in the designated Snellville Towne Center Entertainment District outside of the designated area or into any vehicle.
  - g. Alcohol may not be carried onto any street except during the temporary period of crossing a street inside designated crosswalks, or if the Snellville Police Department closes a street to vehicular traffic specifically for the purpose of

accommodating an outdoor event. Alcoholic beverages served in the designated Snellville Towne Center Entertainment District may be carried upon the sidewalk.

- h. It shall be unlawful for any person to purchase, distribute or consume alcoholic beverages outside of the timeframes provided in sections 6-90, 6-187 and 6-190 of this Code.
- i. The alcoholic beverage cannot be carried into an establishment that does not serve alcohol unless permitted by the establishment."
- Section 2. (a) It is hereby declared to be the intention of the Mayor and Council that all sections, paragraphs, sentences, clauses and phrases of this Ordinance are or were, upon their enactment, believed by the Mayor and Council to be fully valid, enforceable and constitutional.
- (b) It is hereby declared to be the intention of the Mayor and Council that, to the greatest extent allowed by law, each and every section, paragraph, sentence, clause or phrase of this Ordinance is severable from every other section, paragraph, sentence, clause or phrase of this Ordinance. It is hereby further declared to be the intention of the Mayor and Council that, to the greatest extent allowed by law, no section, paragraph, sentence, clause or phrase of this Ordinance is mutually dependent upon any other section, paragraph, sentence, clause or phrase of this Ordinance.
- (c) In the event that any phrase, clause, sentence, paragraph or section of this Ordinance shall, for any reason whatsoever, be declared invalid, unconstitutional or otherwise unenforceable by the valid judgment or decree of any court of competent jurisdiction, it is the express intent of the Mayor and Council that such invalidity, unconstitutionality or unenforceability shall, to the greatest extent allowed by law, not render invalid, unconstitutional or otherwise unenforceable any of the remaining phrases, clauses, sentences, paragraphs or sections of the Ordinance and that, to the greatest extent allowed by law, all remaining phrases, clauses, sentences, paragraphs and

sections of the Ordinance shall remain valid, constitutional, enforceable, and of full force and effect.

**Section 3.** All ordinances and parts of ordinances in conflict herewith are hereby expressly repealed.

## RESOLUTION OF THE CITY OF SNELLVILLE GEORGIA (the "CITY") AUTHORIZING PARTICIPATION IN AN AMICUS BRIEF IN THE CHANG V. CITY OF MILTON APPEAL PENDING BEFORE THE GEORGIA SUPREME COURT

WHEREAS, the <u>Chang v. Milton</u> litigation involves a claim of liability against the City of Milton, Georgia, for personal injuries due to a 2016 vehicle collision with a fixed obstruction (a masonry planter) located on City-owned right of way where the obstruction was outside the motoring lanes of travel;

**WHEREAS**, the masonry planter had been at the same location since 1992 and had never been the subject of a complaint or prior accident;

**WHEREAS**, at the trial court, the City of Milton was found to be partially at fault and a jury awarded money damages against the City of Milton of \$35,000,000;

WHEREAS, on September 16, 2024, the Court of Appeals affirmed the findings of the trial court, <u>City of Milton v. Chang, et. al.</u>, 373 Ga. App. 667 (2024) (Court of Appeals ruling);

**WHEREAS**, on June 24, 2025, the Supreme Court of Georgia granted certiorari, Supreme Court docket number S25G0476;

**WHEREAS**, the Georgia Supreme Court identified three issues upon which it wanted the Parties to focus in their appellate briefing:

- Is the design and placement of objects on a shoulder of a roadway part of the ministerial duty of a municipality to keep its "streets and sidewalks in a reasonably safe condition" or is it a governmental function? Compare Mayor, Etc., of Dalton v. Wilson, 118 Ga. 100 (44 SE 830) (1903) with Town of Fort Oglethorpe v. Phillips, 224 Ga. 834 (165 SE2d 141) (1968). See generally OCGA § 36-33-1.
- 2. Is the placement of a planter on the shoulder of a roadway a "defect[] in the public roads of [the municipality's] municipal street system"? See OCGA § 32-4-93 (a).
- 3. For municipal immunity to be waived under the circumstances of this case, must the plaintiff show that the municipality violated its ministerial duty to keep its "streets and sidewalks in a reasonably safe condition" and that the planter on the shoulder of the roadway is a "defect[] in the public roads of [the municipality's] municipal street system"? Please address the interplay between OCGA § 36-33-1 and OCGA § 32-4-93 (a).

**WHEREAS**, the CITY believes that answers to the above legal questions are of significant value to its citizens and residents;

<u>WHEREAS</u>, the CITY believes that Supreme Court guidance on such questions may lead to the Court of Appeals ruling being overturned

**WHEREAS**, the CITY believes the Court of Appeals ruling is inconsistent with existing legal precedent; and,

**WHEREAS**, the CITY believes that it is in the best interests of the health, welfare, and safety of its citizens that the Court of Appeals ruling be reversed and that the questions presented by the Supreme Court be answered in a way that benefits Georgia's' cities.

**NOW THEREFORE BE IT RESOLVED**, that the CITY does hereby authorize participation in an amicus brief before the Georgia Supreme Court asking that the Court of Appeals ruling be reversed and that the Supreme Court's three proffered questions be answered in a way that is legally advantageous to Georgia's cities. An amicus brief so tendered may include the City's name as a participating party.
