Next Level Turfgrass Advice

Options:

- 1. Total reworking of lawn (Highest price option)
 - a. Remove 4-6" of compacted soil/gravel
 - b. Rework drainage problem areas
 - c. Re-grass with newer variety of Bermuda

*This option will have immediate improvement to growing medium and provide longer term management for high traffic use with additional cultural practices.

- 2. Partial renovation of lawn (Median priced option)
 - a. Includes loosening and amending soil at main thoroughfare entrance and other bare areas to include re-grassing of weaker areas.
 - b. Could include improved drainage.

*This will give immediate improvement to worse areas of lawn but will not eliminate future needs with ongoing traffic.

- 3. Perform consistent, scheduled cultural practices
 - a. During season increase soil amendments and fertility treatments to strengthen existing lawn
 - b. Sod bare areas, then as needed from damage

*Provides essential care for this high use Towne Center lawn area with least disruption. This gives minimal improvement to existing soil conditions.



Agenda Item: Consideration and Action on Approval of Proposal for Roof Replacement

<u>Background</u>: On January 9th, we discovered that the roof had leaked causing the interior paint in the cupola area to bubble. We contacted the GIRMA-approved company, Parker Young, to assess the problem. During the assessment, they realized that there were problems with the TPO on the roof. Parker Young told us that GIRMA will cover the interior repairs, but the roof would also need to be replaced. Both Parker Young and the City contacted GIRMA about the issue. In response, GIRMA will cover the costs associated with the interior damage, and declined coverage on the existing roof due to age and normal wear and tear. We checked the 20yr warranty and it is just a manufacturer warranty of the material itself only (TPO). Where the roof leaks is not a direct issue of the material or defect in the material so there is no coverage in what warranty remains.

Financial Impact: Amount to complete the project in the amount of \$103,896.79.

<u>Recommendation</u>: Approval of the proposal to repair/replace the roof before the spring storm season.

Action requested: Vote to approve the proposal from Parker Young.
