# Cobblestone Report Snellville DDA October 22, 2024

## B. Cobblestone Report

# **Property Management**

C-200 Executive Suites toilet has been replaced.

G-100 toilet insert was replaced.

C-104/5- The tenant's patient peel and stick tile bathroom floor has to be replaced. The existing pedestal toilet is unsafe for handicapped patients. Dr. Abdalla has agreed to renew his lease for 3 years. As a part of the agreement, the DDA will install LVT flooring and replace both the pedestal toilet and the shell sink at a cost of approximately \$6,500.

There are 3 pedestal toilets remaining in the complex at this time.

E-102. Staff is in discussion with the current tenant in D-102 about relocating to E-102 or to consider relocating one counselor into C-215 (with the board's permission).

A 2<sup>nd</sup> floor tenant in the D-building has had flies coming in the office through the windows. The exterior of those windows will be examined and caulk applied as needed. The remaining 2<sup>nd</sup> floor windows will be assessed to determine if caulk, paint, etc. is warranted.

The exterior of all 2<sup>nd</sup> floor windows have been inspected. Thirteen second floor window frames on Buildings D and F have an immediate need for repair due to wood rot. The cost for this repair is \$175/window and includes wood replacement, seal, primer, and paint. Total cost of this project is \$2,275.

In addition, there are 46 2<sup>nd</sup> story windows that need to be sanded and repainted as well. The cost for each is \$75 for a total cost of \$3,450.

Multiplex applied paint to windows affected by the construction work. It appears that they did not sand first resulting in paint peeling around the windows. Jesus has sanded, primed, and painted all vacant suites and will be starting to repaint all windows as he can. Jan has reached out to Larry for an explanation and she will report what is said back to the board.

## Marketing and Leasing

New Facebook videos are up with a tenant testimonial and "A Day in the Life of Cobblestone". Coming in November "A Day in the life of a Cobblestone Tenant".

Crexi and Loopnet have been updated with suggested verbiage from DDA and City for "walkability" from Cobblestone to surrounding businesses.
