I. Call to Order

Lisa called the meeting to order at 6:10 pm. The last Advisory Board Meeting was November 3, 2020.

II. Old Business

Lisa asked for approval of the November 3, 2020 minutes. Brittany motioned for approval, Nicole seconded the motion. The minutes were approved.

Vote was 5 in favor, 0 opposed, 1 absent.

III. New Business - Under COVID

- a. "VOTE – Adjustment Field Rental fees (not including softball fields). Current rent for Briscoe, largest field (no lights), Staley, and Cotter fields is \$50 for 2 hours and \$75 with lights. Tournaments usually rent for the whole day.

Proposed 2 hour fees for tournaments only: Briscoe \$150; Cotter \$100 w/o lights, \$150 with lights; Staley \$75 without lights \$100 w/lights. Maintenance and rental attendant fees would be adjustable (rental attendant required for over 150 people)

Brittany motioned to approve, Carole seconded the motion.

Vote was 5 in favor. Approved.

- b. "ATHLETICS – Spring Leagues" agenda item: 185 registered for soccer, 193 for NFL flag football.
Youth baseball and softball practices started in March.
GAC football practice and cheer starts in May.
Adult softball: 3 men's/6 co-ed & Ladies kickball pop-up play.

- c. "Senior Center" agenda item. Still closed & following Gwinnett County. COVID programs: 4 regular exercise classes, paint classes, drive-in bingo, Family Feud. 36 trips to Gwinnett Place Mall for COVID vaccinations 40 appointments/36 trips/27 complete vaccinations.
- d. Pool is pre-opening 5/22 & 5/23; regular opening 5/28 with a modified capacity of 150 (to re-evaluate as needed); swim lessons reduced to 4 per class, swim club with no meets, timing swimmers during practice.
- e. Special events: successful Car show in March, 135 cars; next one in November; Snellville days cancelled for 2021; Public Safety Night, June 8.
- f. Park Master Plan: Town Center ground breaking March 18, design plans for park moving forward.
