CALL TO ORDER

Mayor Bender called the meeting to order at 6:30 p.m.

REVIEW REGULAR BUSINESS MEETINGS AND PUBLIC HEARING AGENDA ITEMS

Attorney Ross advised that an Executive Session is needed for legal and real estate and gave updates on Qualify of Life Court as well as the status of Snellville Pavilion.

Update of Ongoing Projects [Bender]

City Manager Sanders gave an update on the Towne Center as well as other City projects.

Discussion About Wall Along Highway 78 [Schulz]

Mayor Bender asked about purchasing paint and painting the wall a solid color. Consensus was to move forward with the idea so the Mayor will look into the best color to use.

- To authorize negotiations to purchase, dispose of, or lease property; authorize the ordering of an appraisal related to the acquisition or disposal of real estate; enter into a contract to purchase, dispose of, or lease property subject to approval in a subsequent public vote; or enter into an option to purchase, dispose of, or lease real estate subject to approval in subsequent public vote, which is excluded from the Open Meetings Act pursuant to Section 50-14-3(b)(1)(C).

Upon a motion by Council Member Emanuel, 2nd by Council Member Destang, the meeting was closed, with Council Members Destang, Emanuel, Lenski, Mayor Pro Tem Warner and the Mayor present and voting in favor.

The meeting was closed at 7:03 p.m.
