Discussion of RCut Intersection at Highway 124 and Wisteria Drive [Bender]

City Manager Sanders advised that Georgia Department of Transportation (GDOT) would not approve a three way T intersection at the location, only the RCut. The City continues to work with Larry Kaiser of Collaborative Infrastructure Solutions on different ideas for Towne Center traffic flow. Mr. Kaiser presented different solutions and said he would bring them to GDOT for review.


