2nd Reading – #RZ 16-03 CUP 16-03 CUP 16-04 – Consideration and Action on applications by Stein Investment Company, LLC (Virginia) and ISTAR Bowling Centers I, LP to amend the Official Zoning Map of the City of Snellville from BG (General Business) District to HSB (Highway Service Business) District; request for a Conditional Use Permit for a Mini-Warehouse Storage Facility; request for a Conditional Use Permit for a Commercial Recreation Enterprise (bowling center) and request for variance from the Zoning Ordinance for the 3.05± acre tract of the 3.79± acre property located at 2350 Ronald Reagan Pkwy., Snellville, Georgia (Tax Parcel #5040 111)

Planning Director Jason Thompson spoke about the application. He advised that Staff recommended approval with conditions.
